The State Health Agency (Ayushman Bharat-PMJAY) J&K has invited Bids from C&AG empanelled Chartered Accountant firms for providing their services as Statuary Auditors under the Scheme Ayushman Bharat-PMJAY in respect of State Health Agency & District implementation Unit of J&K for the financial year 2018-19, 2019-20, 2020-21, & 2021-22 as per the guidelines issued by the National Health Authority, Govt. of India with minimum fee of Rs. 30,000/- (including TA/DA & GST) per year for SHA & Rs. 5,000/- (including TA/DA & GST) per year per district in compliance to the notification of ICAI regarding responding to tenders. Interested CA Firms of repute and duly registered should send their expression of interest to the office of the Chief Executive Officer, Ayushman Bharat PM-JAY, J&K by or before 04th Feb., 2022 (04.00 pm) and shall be opened on 7th Feb., 2022 (11.00 am). 1. SCOPE OF WORK: -

- i) To make review of the system of book keeping & accounting.
- ii) To make such tests and enquiries as the auditors consider necessary to form an opinion as to the reliability of the records as a basis for preparation of Accounts.
- iii) To verify accounts with reference to the books of accounts i.e. ledgers, journal and other subsidiary and supporting records to see that the accounts are in agreement with the books of accounts.
- iv) To make a review of the Income and Expenditure Account/Receipt & Payment Account and the Balance Sheet in order to make a report stating, whether in the opinion of the auditors, the financial statements are presented in conformity with the generally accepted accounting principles and the items therein are described in such a way to give a true and fair view of the financial position and results of operations of the entity.
- v) Adequacy of Internal Audit System.
- vi) System of Physical Verification of Inventory & Fixed Assets.
- vii) Regularity in Payment of Statutory Dues.
- viii) Checking of submission of Utilization Certificate.
- ix) Preparation of TDS statement and assist the office for timely payment of TDS. The TDS certificate to the concerned parties shall also be generated by stipulated dales and TDS returns shall also be filed within the stipulated date.
- x) Preparation of Statement, payment, filing of return etc. of any other taxes levied by Government from time to time.
- xi) Any other work assigned relating to accounts/statutory requirements etc.
- xii) Providing opinion on the matters relating to Income tax, GST, etc.as per Government notification from time to time.
- xiii) The Auditor will have to Visit at our premises in all Districts of J&K and perform Audit there as per the guidelines of the NHA.
- xiv) Separate Audit Reporting of Each District should be prepared and a Consolidated Report should also be prepared.

2. PRE-QUALIFICATION CRITERIA OF THE CA FIRM: -

The technical bids of only those CA firms will be considered, which satisfy the following eligibility criteria:

- i) The Chartered Accountant Firm should be empaneled with the office of C&AG of India for the Financial Year 2021-22.
- ii) The Chartered Accountant Firm is required to have Permanent Account Number (PAN) & GST Number.
- iii) The Chartered Accountant Firm should be a Partnership Firm with at least 2 CA Partners and one amongst them should be a FCA (Fellow Chartered Accountant).
- iv) The firm or any partner of the firm should not be black listed by any Government Departments, C&AG, PSUs or any other organization in respect of any assignment or behavior. The firm has to submit the No blacklisting certificate as per **Annexure I.**

- v) The CA firm should submit their turnover for the last three years in the format attached at **Annexure II.** Minimum Average turnover for Last 3 Years should be atleast Rs. 50 Lakhs.
- vi) The CA Firm should have been in operation for minimum 10 years. The firm should have undertaken and completed at least 3 assignments (of different organizations) in Last 3 years in J&K related to Audit of Annual Accounts of Central Autonomous bodies (CAB) / other state government organization/ Public Sector Undertakings (PSUs) relating to Health & Medical Education Department (to assess ability of doing this audit of J&K Stationed Partners of CA Firm). Firms should submit details of experience required in format attached at **Annexure III.**
- vii) Partnership firm should have at least one FCA engaged in full time Audit work and submit details of proprietor and/or partners in format attached at **Annexure IV**.
- viii) The CA Firm should have atleast one Stationed Partner in J&K who has done Certificate Course in Public Finance and Govt. Accounting. (To assess ability of J&K Stationed CA Partners to do Govt. Audit)

Note: Firms Scoring 70 Points & Above shall be eligible for opening of Financial Bids, Firm Quoting Lowest shall be Awarded Tender. In case Two or more Firms are L1 than Firm having maximum points shall be awarded Tender, in case Two or More Firms get 100 Points and are also L1 then Firm having Highest Points as per Latest CAG Empanelment Ranking for FY 2021-22 shall be selected.

3. PAYMENT TERMS: -

- i) The professional fee quoted by the firm shall be valid for the entire contract period. Payment shall be made on completion and submission of signed Audit Report.
- ii) Statutory Taxes will be paid at prescribed rate during the contract period.
- iii) TDS will be deducted as per prevailing rates prescribed in the Income Tax Act from all payment.
- iv) Minimum Professional Fees per year as Statutorily required by ICAI is Rs. 1,30,000 p.a. (inclusive of GST)

4. OTHER GENERAL TERMS: -

- i) Format of Application must be completely filled in. Incomplete applications will be rejected outright.
- ii) Please ensure that date of establishment of registered office, Branch office, details of all partners into the firm should be invariably indicated in the application.
- iii) All submitted documents should be signed by a Partner with his name and under the seal of the firm.
- iv) Any application received after the stipulated date & time, due to any reason whatsoever, will be rejected outright.
- v) CA Firms are requested to visit the office of the undersigned for further clarification/ query/ exact scope of the work etc.
- vi) No proposal shall be entertained in joint venture/Consortium.
- vii) Period of appointment can be extended upto five years subject to approval of competent authority and satisfactory performance of the audit firm.

- Application Part A duly filled pre-qualification-cum-technical Bid along with all supporting documents duly signed with Seal of the authorized partner and should be submitted in a sealed envelope super scribed as 'PRE-QUALIFICATION AND TECHNICAL BID'.
- ii) **Application Part B** duly filled Financial Bid should be submitted separately in a separate sealed cover super scribed as 'FINANCIAL BID'.
