Subject: Minutes of the meeting of 1st Medical Committee Meeting under Ayushman Bharat PMJAY/SEHAT

1st Medical Committee meeting under Ayushman Bharat PMJAY/SEHATwas held on 06th March, 2021 at meeting hall, National Health Mission Office, Nagrota Jammu under the chairmanship of Chief Executive Officer, State Health Agency J&K. Following officers/officials participated in the meeting:

Agenda 2: Rejection of Cases at Pre-Auth & Claim Processing Level

A threadbare discussion was done on the rejection of cases by the insurance company, both at PPD and CPD level. Some examples were discussed thoroughly and following decisions were taken:

i) Rejection of cases where Pre-Auth was taken on the basis of silver record: The chair was briefed about the such cases which were processed on the basis of silver records as per circular issued by State Health Agency wherein it was communicated to the insurance company for considering all such delayed pre-Auths where treatment has been done before 15th Jan 2021, J&K. These cases were rejected by the insurance company on the basis of non-adherence of TAT guidelines both at PPD as well as CPD level.

DECISION: It was decided that all such cases (PPD/CPD) will be revoked immediately.

- ii) Seal & Stamp: A cases was discussed which was rejected by the insurance company for not uploading OPD consultation of a Nephrologist. It was briefed to the chair that all public hospitals does not have full time Nephrologists and therefore public hospitals will not be able to provide seal and stamp of Nephrologists on documents like OPD consultation, Investigation reports, HD charts etc.
- iii) **DECISION:** It was decided that in public hospitals seal and stamp shall not be mandatory for processing **all** the cases across the specialties. For reports from any non NABL private Lab. Medical Coordinator PMJAY (Public/Private Hospitals) will affix sign and stamp

on all the necessary reports. Moreover, for public hospitals MRD number mentioned in the documents should be enough for ensuring genuineness of the documents uploaded.

In case of Haemo/peritoneal dialysis, done in a private hospital/dialysis center, uploading of OPD consultation once in a month shall be mandatory. In public hospitals, OPD consultation of any trained MBBS doctor shall be enough for approval of the Pre-Auths/Claims.

- iv) Authentic sign of treating doctor: A case from Shri Mata Vaishno Devi Narayana Superspecialty Hospital was discussed which was rejected at Pre-Authorization level by the insurance company due to the reason for not providing Authentic Sign of treating doctor. As per analysis done everything with pre-auth was genuine except a very minimum deviation in the signature style.
 - **DECISION:** It was decided by the chair that these slight mistakes must not act as sole reason for rejecting the Pre-Auths and insurance company was directed that before rejecting any pre auth of any hospital on the basis of any suspicious documents uploaded, the field staff should be deputed for field verification of those documents.
- v) Standalone Diagnostics: The chair was briefed about the rejection of Coronary Angiography (CAG) cases done by the insurance company with a justification that Standalone Diagnostics are not covered under AB-PMJAY –SEHAT. The chair sought opinion from the HoD Cardiology SKIMS Soura and HoD Cardiology Super- Speciality Hospital Jammu regarding the blocking of Standalone Diagnostics like CAG and both were with the same opinion that this procedure should be covered under the scheme. However, there was difference of opinion regarding the package code of Health Benefit Packages for blocking this procedure in TMS.

DECISION: It was decided that the case will be referred to Medical Committee of National Health Authority (NHA) for proving package code under which Coronary Angiography can be booked in TMS.

- vi) Out of Pocket: A case of PTCA from SKIMS Soura was discussed which was rejected by the insurance company at claim level just because the field audit of the insurance company suggested that hospital charged money from patient.
 - **DECISION:** It was decided that as per MoU /guidelines insurance company must not reject any such cases without consulting State Health Agency, J&K for doing so. State Health Agency will devise a mechanism for timely disposal of Out-of-Pocket cases in the hospitals and a circular in this regard shall be communicate to all the hospitals.
- vii) Other Decisions: Following were the other decisions which were taken by the committee:
- a. Revocation of all TAT related CPD cases
- b. Review of all Pre-Auth rejected cases by the insurance company.
- c. Review/Revocation of CPD cases rejected because of following reasons: <u>Investigation not covered, Sign & Stamp, KFT Report, OPD Consultation, Miscellaneous, BIS Audit form, Aadhaar Card.</u>

The meeting ended with vote of thanks to the chair
