Assignment Title: Hiring an Agency for conceptualization and carrying out of IEC activities for State Health Agency, an autonomous body under the Department of Health and Medical Education, Govt of Jammu & Kashmir.

1. Background

State Health Agency: The State Health Agency (SHA) an autonomous body set up under the aegis of Department of Health and Medical Education, Government of Jammu & Kashmir, is registered under J&K Societies Registration Act VI (1941 A.D) (Reg. No.: D18C/7188-RS/916). SHA is the nodal agency implementing "Pradhan Mantri- Ayushman Bharat Yojana - PM-ABY, a Government of India scheme, requires to provide health insurance cover to the extent of ₹ 500,000 per annum on a family floater and cashless basis through an established network of health care providers to the AB PM-JAY Beneficiary Family Units and also implementing AB PM-JAY SEHAT to provide cashless medical insurance cover to 21 lakh beneficiary families under the schemes.

Objective of the assignment

2. The objectives of the Services are outlined as below.

SHA intends to hire the services of a Public Sector Undertaking for provision of Information Education Communication Services - IEC Services. The successful bidder is required to provide certain defined services to SHA, Govt of J & K. Broad objectives of the assignment are given below.

- a) IEC material conceptualization, designing and finalization of the material;
- b) printing and distribution/ delivery at different District Head Quarters in the State of J & K.

3. Invitation

The State Health Agency, (SHA) now invites eligible qualified and experienced Public Sector Undertakings who wish to undertake services for "conceptualization and carrying out of IEC activities for State Health Agency", Govt of J & K. Interested PSUs should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. Shortlisted agencies will be required to submit detailed technical and financial proposals at a later stage. The filled in EoI should reach CEO SHA J&K Office on or before 5.00 PM of 1st August, 2021

a) Eligibility criteria:

Agencies who fulfill the following qualifying criteria only will be considered for the assignment:

- a. The agency should be a Public Sector Undertaking promoted by Govt of India or any State Govt. Other than PSUs are not eligible to bid.
- b. The agency should possess <u>at least 3 years of experience in the field of</u> <u>communication, Information Technology and IEC.</u>
- c. Average turnover in the last 3 years should be <u>at least INR Ten Crores</u>
- d. The agency should have the experience of working for Central/ State Government/ Public Sector undertaking/ Autonomous Bodies under Central or State Governments.
- e. The agency should have adequate staff strength and experts having experience and professional qualification. Brief CVs highlighting the experience listed should be furnished
- f. The agency should have the resources to implement quality, coordination and value addition functions to the products and services of the various service providers to produce a comprehensive communication and branding package, factoring in both strategic and operational communication. The agency may furnish appreciation letter with completion certificate from Government/ Ministries/ Department and/ or agencies that they have worked with.

PSUs may associate with other firms to enhance their qualification. The "Association" may take the form of a joint venture (with joint and several liability) and this should be stated clearly in the submission.
